Our team deliver real results in terms of maximising employees' take home pay while minimising employer spend. PaycheckPlus works with Irish, UK and international clients operating across a range of sectors and locations with staff numbers ranging from one employee to several thousand. Given the relatively small market in Ireland, the company have focused on an export strategy from an early stage. With a reliance on country specific laws and regulations in relation to payroll, PaycheckPlus needed to be creative. Their commitment to compliance has made them the preferred payroll provider to many compliance focused organisations.

By helping clients understand the factors affecting the remuneration PaycheckPlus offers assurance for one of the biggest spends in most companies.

Anne has built the international aspect of the business and international clients now account for over 40% of PaycheckPlus' business. Anne also offers services to Irish companies looking to expand into other markets. *"For Irish clients looking to develop an international presence, we have partnerships with multi-national payroll companies.
